MINUTES OF THE MEETING OF THE BOARD OF PARK COMMISSIONERS OF MILL CREEK METROPARKS

A Regular Meeting of the Board of Park Commissioners of Mill Creek MetroParks was held on Monday, July 8, 2024.

The meeting opened at 5:00 p.m., with recitation of The Pledge of Allegiance.

Public Comments to the Board: (see sign-in sheet)

- Jerry Serbel stated that he lives on Bears Den Road and has been complaining about a tree on Roseway and Bears Den Road that has finally fallen down but is at the meeting because he is an advocate for the deer. He believes hunting in Mill Creek Park is stupid. He doesn't think it is right to hunt God's creatures. He enjoys the Park. He questions why we are doing the same thing that we did as last year.
- Marianne Whitehouse identified herself as the widow of Bill Whitehouse. Mary Anne asked a visitor to put down a Save the Deer sign. Bill lived for 87 years and passed last September 11, 2023. She stated that she was told by a Board member that a memorial would be identified to honor Bill. She is in attendance simply to share that nothing has been done. She doesn't think that it is too much to ask for a trail to be named in honor of Bill.
- Mike "Mickey" Drabison stated that he attended the meeting at Fair Park with Aaron today and he inquired about an event titled "Forest Babies." Mike stated that Aaron made a quote about all of the deer having to go.
- Lana Van Auker thanked Mickey for his comments. Lana shared that Bill was an amazing man. Lana shared that she owns various parcels of land. She read a prepared statement against the Park's deer management program and in support of contraceptive programs. Lana stated that the number of hunters worldwide is declining. She ended with a quote from Jane Goodall.
- Ray Thomas referenced his previous comment from back in March regarding concerts at the Morley Pavilion. Greg referenced a recent program at Lanterman's Mill. Greg stated that we did not provide firewood to cook the hot dogs. Greg went to the Morley during this past month and noted the low level of attendance. Greg stated that the promotion of the concerts needs to happen a year in advance.

Commissioner Comments:

- Lee Frey asked if someone on staff would get in contact with Jerry to look at the tree that he is concerned about.
- Lee Frey moved that we name a trail at FNC in honor of Bill Whitehouse. The motion was seconded by Paul Olivier. Jeff moved to table Lee's motion until the issue can be discussed further.
